- Policy and Funding Updates (10 minutes)
 Rebecca Long, MTC
 - SB1 funding for local streets and roads, increase and funding and taxes, there's not much more appetite for more funding.
 - SB152 that bill died, sponsored by MTC to increase the ATP funding, through CTC. Everywhere in the state needs ATP, Cal Bike and Cal Walks did not support the bill.
 - SB127- made it to the governor's desk. Idea was to mandate that to develop projects in the State Highway Operation and Protection Program (SHOPP), local roads that are state highways. Make changes to improve bike ped improvements. The governor felt that it was too prescriptive and costly.  - Executive Order N1919 has focus on transportation emissions. Wants Caltrans to use discretionary funding towards active transportation. Use administrative authority. Clear through new Caltrans Director, that he is supportive of transportation.







- SB277 similar to ATP bill, that would increase formula of state local partnerships program. 50% sent by formula and 50% administered by CTC. Rationale for vetoing was getting back to focus on climate change to implement the state's priority. Another area where the CTC might fund more transit projects over bike/ped.
- SMART Train was a local sales tax local and regional decision. Bringing down emissions by 19 percent. Funding that bike path might compete well for the State local partnership application.

 - 4-year initiative in effort to deepen SRTS efforts in High Schools
 - Funding innovative and learning projects.
 - So far it has been year long grants, with up to 10K to vendors
 - Some of the barriers we heard include: small funding amount, the energy to do relationship building with new age group, evaluation requirements, and not be able to focus on regional issues.
 - As part of the revised approach, we are interested in: regional task forces, a two-year grant period, and regional coordinators
